- 1. **Minimum Eligibility Criteria**: CA firm, ICWA firm with registered office at Bhubaneswar and having minimum 10 years of experiences with average turnover of Rs. 20 lakh for last three financial years.
- 2. **Monthly Consulting Charges**: The Consulting Charges shall be Rs. 30,000/-per month (excluding applicable GST). No other allowances shall be admissible. The incidental expenses for dealing the cases shall be reimbursed.
- 3. **Scope of works:** The Firm Shall be engaged as GST Consultant at Odisha State Beverages Corporation Limited with following scope of works;
  - A. Compliance related to GST
    - 1. To guide and assist for proper calculation and timely deposit of GST Liability on monthly basis as per the provisions of GST Act.
    - 2. To guide and assist for preparation of filing of monthly GST Returns and ensure proper and regular filing of returns.
    - 3. To opine and guide on any GST issue, which may arise and also arrange compliance of the same.
    - 4. Compliance of all notices/ Show Cause/ letters from GST Authorities received.

### B. Compliance related to Service Tax

- 1. Appearance before CESTAT & Higher Forum as when required.
- 2. Appearance before Central excise & Service Tax Authorities in case of issues arised relevant to Service Tax period.
- 3. Appearance before any intelligence authority.
- 4. Assist the Senior Advocates engaged by the OSBC at Higher Forum.

#### 4. Other terms and conditions:

The tenure of engagement shall be initially one year and subject to further renewal depending the assessment of the performance.

A breach of above scope of works by the GST Consultant shall be consider sufficient ground for termination of engagement.
