- 2) (a) The "Bidders" have to furnish copy of the RoR showing ownership of the land on which the go-down/warehouse is situated and area details with site map.
  - (b) The copy of the Building plan with Building photograph needs to be submitted. In all cases distance of the location from the National Highway/State Highway is to be mentioned preferably by a rough sketch. The width of the approach road to the go-down/warehouse along with its type (kuccha or pucca) is to be mentioned which should be fit for plying of heavy loaded vehicles.
- **3)** There should be a separate building with a minimum floor area of 1200 sqft. Within the same premises for using as office in which adequate ventilation with lavatory facility and water supply will be available.
- **4)** The rate per Sq.ft. of the go-down/warehouse/office quoted by different "Bidders" will be compared and the lowest rate quoted will be considered for acceptance subject to negotiation if required.
